GENERAL PROVISIONS

§ 93.01 PRICE OF CEMETERY LOTS.

The price of all lots and all other charges in the cemetery shall at all times be fixed and determined by the Town Council.

§ 93.02 PERPETUAL CARE FUND.

(A) There is created a Perpetual Care Fund for the care, maintenance, and upkeep of the cemetery located in the town. This fund is to be designated on the books and records of the Town Council and on the books and records of the cemetery as the Perpetual Care Fund.

(B) The Perpetual Care Fund shall be maintained by the addition to the fund of sums of money obtained pursuant to the sale of grave sites in an amount established by the Council.

BOARD OF CEMETERY TRUSTEES

§ 93.10 ESTABLISHMENT AND DUTIES.

There is hereby created a board to be known as the Board of Cemetery Trustees to advise the Town Council on the use of privately donated funds to the Town Cemetery. The Board shall consist of five members to be appointed by the Council.

§ 93.11 MEMBERS.

(A) The members of the Cemetery Board shall be either residents of the town or owners of lots within the cemetery, either by purchase or by inheritance. One of the members of the Board shall be a member of the Town Council and shall, by virtue of that office, be President of the Board of Cemetery Trustees.

(B) The Board shall consist of five suitable persons, having the qualifications set forth in this chapter, each of whom shall serve for a term of four years from the date of their appointment. The Town Council shall, at their regular session in the month of January in each year, appoint one or two persons as the case may require, to serve as members of the Board.

§ 93.12 POWERS AND DUTIES; COMPENSATION.

The Board of Trustees of the cemetery shall be allowed compensation for their services as the Town Council from year to year shall determine.

§ 93.13 SECRETARY AND SEXTON.

(A) The Town Council may, on or before January 21 of each year, employ a Secretary to the Board of Cemetery Trustees, which person shall be a resident of the town and shall serve as Secretary upon the terms and conditions determined by the Council and specifically at the pleasure of the Council until a successor is elected and qualified. That Secretary may be a member of the Cemetery Board of Trustees.

(B) The Secretary, if employed, shall give bond in the sum of \$2,500 in favor of the town to account of all moneys and property of all kinds coming into his or her hands as Secretary and shall have such duties as the Council shall proscribe.

(C) The sexton, if employed, shall give bond in the sum of \$2,500 in favor of the town to account for all moneys and property of all kinds coming into his hands as sexton and shall have such duties as the Council shall prescribe.
